BOTTOM LINE UP FRONT

For the fictional firm Sample Foods Pte. Ltd. (UEN shown as SAMPLE-UEN-0000A (sample), no real UEN used):

- **EDG (Enterprise Development Grant): 4 of 5 checks read as pass, 1 gap to close.** The gap is proof of financial readiness: the sample accounts look fine, but only Enterprise Singapore can confirm the firm can start and finish the project.
- **PSG (Productivity Solutions Grant): 5 of 6 checks read as pass, 1 gap to close.** The gap is picking a pre-approved item with a matching quote before applying, and keeping the annual S\$30,000 cap in mind.
- **This is a checklist only, never a promise of approval.** Enterprise Singapore reviews scope, results, and provider fit, and can ask for more papers or say no.

So what: close the two gaps below, then apply through the Business Grants Portal. Details and papers per line follow.

How this check was done

Read the free public Enterprise Singapore pages for EDG, PSG, and the PSG questions page (no login, no fee). Those three pages are the only Sources cited.

Two plain notes on what was not used:

- GoBusiness portal pages could not be opened from this run, so no GoBusiness link is cited.
- The ACRA (Singapore company registrar) paid business profile, which shows live shareholder and officer details, sits behind a paid download and was not checked.

Published limits (S\$100 million sales, 200 staff, 30% local equity, up to 50% support) are real criteria from the Sources below, not sample figures.

EDG support note: up to 50% of qualifying costs for local SMEs (small and medium firms); sustainability-linked projects may reach up to 70%. Paid on reimbursement after agreed outputs are met.

PSG checklist — pass / gap + paper needed per line

P1	Firm registered and operating in Singapore	Singapore-registered, local site (sample)	Pass	ACRA search; tenancy proof or utility bill if tool runs at a second site
P2	At least 30% local equity	100% (sample) Singaporean-held	Pass	ACRA search; group chart if part of a group (sample: standalone (sample))
P3	Group sales at most S\$100 million OR group staff at most 200	S\$3,200,000 (sample) and 22 staff (sample)	Pass	Past 3 years signed accounts; group accounts and parents/subsidiary searches if grouped
P4	Item bought or leased is used in Singapore, by the applicant only	Own Singapore site only (sample)	Pass	Site address for rollout; note that holding period runs 1 year from final claim approval

PSG support note: up to 50% of qualifying costs; yearly cap of S\$30,000 per firm for Enterprise Singapore-backed items, 1 April to 31 March. Only the item cost counts, not add-on fees such as delivery.

Papers to gather now

EDG pack: recent ACRA search, signed last-year accounts, project offer, itemised quotes, staff letters, adviser CVs and cert papers where needed, 3-year forward figures.

PSG pack: contact names, past 3 years signed accounts, vendor quote in the full registered name, rollout address proof, and a short note on expected output gains.

At claim time: invoice in the full registered name, full-payment proof showing payer, payee, date, sum, and pass status, plus use proof (tool used at least one month; clear photo of licence or serial number). Keep the item for 1 year from final claim approval.

Honest gaps and limits

- Financial readiness (E3) cannot be cleared on paper here; the reviewing officer applies the money tests.
- PSG item fit (P5) cannot be cleared until a pre-approved item and vendor are named and the quote is matched line by line.
- Live ACRA shareholder and officer details were not checked (paid download, see above).
- GoBusiness portal pages were not cited (could not be opened, see above).
- Timelines move: PSG claims about 6 weeks for a full file; EDG claims about 8–12 weeks. Incomplete files are sent back and may be re-filed when full.

Next steps

1. Pull a fresh ACRA search and sign off the last-year accounts (sample firm to do for real before filing).
2. For PSG, name one pre-approved tool and get a matching vendor quote in the full registered name; do not pay anything first.
3. For EDG, name the adviser, confirm TR 43 / SS 680 papers where needed, and freeze a dated offer with phase and day-rate splits.
4. File on the Business Grants Portal and keep every quote, invoice, and payment proof until well after the claim is paid.
