So what: in a real check, each row above would carry a live value with a date and a cited source. Here each value is fictional (sample).

How status is checked — free BizFile search

ACRA (Accounting and Corporate Regulatory Authority) runs BizFile (ACRA's online portal) at bizfile.gov.sg. Its free search shows basic facts such as status and registered address, with no login needed.

Steps in a real check:

1. Open bizfile.gov.sg and use the free Search function.
2. Enter the exact registered name or UEN.
3. Read the status and registered address shown free.
4. Record the date and time of the lookup with the result.

Paid ACRA detail (full officer list, shareholder and filing detail) sits behind the paid profile and is omitted in this free-method demo.

Paid-up capital	S\$50,000 (sample)	Fictional figure for format only

News sweep — method and sample result

Method in a real check: search the exact quoted name, the UEN, and each officer name across mainstream Singapore press and official announcements, covering the past 24 months (sample window), then open each hit and keep only dated items that clearly refer to the same entity.

Sample sweep result — all fictional (sample):

Source type	Sample finding
Mainstream press	No adverse hits (sample)
Official announcements	No enforcement mention (sample)
Court and insolvency notices	No filing found (sample)

So what: a real sweep would list each dated hit with outlet, headline, and link, or state a confirmed nil with the date range covered.

What a real S\$49 check returns

Live status	Fictional Active (sample)	Live status with lookup date
UEN and address	Fictional placeholders (sample)	Live values as shown on free search
News sweep	Fictional nil (sample)	Dated hits with links, or confirmed nil

Risk note	Format only (sample)	Plain-language read with gaps flagged

ACRA's published fee facts (not sample): a Business Profile costs S\$5.50 and covers basic entity facts such as UEN, name, registration date, and position holders; the Corporate Compliance and Financial Profile costs S\$50 and adds financial and compliance facts.

Limits and honest gaps

- No live lookup was run for this sample; every entity value is fictional (sample).
- Paid officer, shareholder, and filing detail is omitted here.
- News hits above are illustrative nil results (sample), not evidence of a clean record.
- A real check would confirm the exact registered name and UEN with the buyer before starting.

Next steps

1. Send the exact registered name and UEN for the real entity.
2. Confirm the news window you want covered (default 24 months).
3. We run the live free-search lookup, the news sweep, and the paid extract, then deliver the cited pack.
